Assistant Professor of Medicine, Icahn School of Medicine at Mount Sinai; Medical Director, Thrombosis Services Program, Mount Sinai Health System The estimated number of patients requiring anticoagulation therapy for treatment of venous thromboembolism (VTE) is anticipated to double by 2050. Anticoagulants, which are essential for treatment and prevention of VTE, have persisted as the leading class of medications associated with emergency department visits for adverse medication events for more than a decade. The advent of direct oral anticoagulants (DOACs) has been shown to be safer than alternative agents, such as warfarin, in clinical trials but not in real-world practice. Frequent inappropriate dosing and prescribing have been documented in numerous studies. Enhanced efforts around the improved use of anticoagulants for VTE and other thromboembolic disease states are imperative to change the current unfavorable trajectory of patient harm due to these high-risk, yet essential, therapies.

In this webinar, Dr. Burnett will define anticoagulation stewardship and describe practice-level initiatives and national-level momentum behind these types of programs. She will also discuss the role of pharmacists within the multidisciplinary team to promote anticoagulation stewardship for VTE patients throughout the continuum of care. Finally, she will summarize relevant clinical resources to aid clinicians in optimizing the care of VTE patients.
